Revision of pay scale of various categories of posts in H.P. Housing and Urban Development Authority.

A copy of Notification No. Fin-(PR)B(7)-1/2021 dated 3<sup>rd</sup> January,2022 endorsed to all Heads of Departments in Himachal Pradesh amongst others is enclosed.

The Board of Directors of HIMUDA has accorded approval in its meeting held on 28.02.2022 [vide item No.50(24)] to adopt the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 as well as revised pay scales effected from the first day of January, 2016 alongwith allowances in the case of HIMUDA employees.

The HIMUDA employee shall exercise option in the Form appended to these rules so as to reach the authority specified in Sub-rule (2), within a period of one month from the date issue of this letter.

The arrears with effect from first the January, 2016 to 31st December, 2021 shall be paid in such manner and at such time as may be approved by the Government.

Therefore, it is advised to prepare pay fixation proposal in the cases of employees working under your Division after completing all codel formalities envisaged in the Himachal Pradesh Civil Services (Revised Pay) Rules, 2022 and send to this office for further examination and approval.
