Subject: Regarding Contributory Pension Scheme (NPS)- option thereof.

Sir/Madam,

It is intimated that the BOD in its meeting held on 19.09.2020 vide agenda Item No. 49 (5) Point No. 3 for consideration has approved as under:-

"To avoid future liability of pension in HIMUDA, it is proposed that new employees not covered under LIC pension scheme of 2008 may be covered under NPS as applicable in the State Government"

Keeping in view of BOD decision, it has been decided before implementation of Contributory Pension Scheme also known as NPS which were notified by the Government of Himachal Pradesh vide Notification dated 15th May, 2003 in HIMUDA, option from the all employee(s) of HIMUDA who were appointed on or before 15.05.2003 and also new employee(s) not covered under LIC pension scheme of 2008 on the prescribed format for option which **is annexed as Annexure-I.**

Therefore, you are advised to get the option form circulated amongst the all employee(s) of HIMUDA who were appointed on or before 15.05.2003 and also new employee(s) not covered under LIC pension scheme of 2008 working under your control. The option of all employee(s) should reach to this office on or before 15th October, 2021, thereafter no option for NPS will be accepted.
