NOTICE INVITING TENDER

The Executive Engineer, HIMUDA Division Parwanoo, District Solan, (HP) on behalf of the Chairman, H.P. Housing & Urban Development Authority invites the sealed bids on percentage rate basis, for the under mentioned work from approved eligible contractors of HIMUDA, HPPWD and HP Jal Shakti Vibhag enlisted in appropriate class. However, successful bidder of HPPWD and HP Jal Shakti Vibhag must get registered in HIMUDA, in appropriate class before signing the contract (As per enlistment rules of HIMUDA 2018). The tender shall be received in my office on or before up to **08.12.2025 up to 11:00 AM** and shall be opened on same day at 12:00 Noon in the presence of the Contractors or their authorized representatives who wish to be present at the time of opening of tender. However, contractor in a particular class shall be eligible to tender for his own class and one class below:-

 - GST Registration and acknowledgement of upto date filed returns of GST.
 - Income Tax return /clearance Acknowledgement, PAN No. and EPF Registration.
- Draft Notice Inviting Tender/Drawings/Specifications can be seen in the office of undersigned or any working day between 10:00 AM to 4:00 PM.
- Ambiguous/conditional tenders or tender by FAX/E-MAIL shall not be entertained/considered in any case.
- The Intending contractors are requested to see the site of work before submitting the tender.
- The earnest money in shape of Demand Draft/FDR duly pledged in favour of Executive Engineer, HIMUDA Division, Parwanoo, District Solan (H.P) shall be received along with application for obtaining tender form. The application without earnest money will not be entertained and out rightly rejected.

The intending Contractors/Firm shall give an undertaking by way of affidavit duly attested and sworn before the Executive Magistrate or Notary Public, clearly stipulating therein that he does not have more than two works in hand in the entire State of Himachal Pradesh and one of the work is nearing completion i.e. at least 90% of the tendered amount.

7. The tender shall be issued on or before **05.12.2025 up to 2:00 PM.**
8. The offer shall remain valid upto 50 days after the date of opening of the tender.
9. If any of the date mentioned above happens to be local/gazetted holiday, the same shall be processed on next working day.
10. Competent Authority reserves the right to reject/accept any or all tenders without assigning any reasons.
11. CGST & SGST will be deducted from the payment bills of contractors apart from other statutory deductions.

Contractor will be reimbursed the claim of EPF on the production of proof of EPF Challan paid to the Commissioner, Provident Fund Shimla and 1% (one percent) Labour Cess will be deducted from the work done and contractor will get himself registered with the labour and employment department under Cess Act, 1996.
