NOTICE INVITING e-TENDER

1. **The Executive Engineer, HIMUDA Division Mandi, District Mandi, (HP)** on behalf of the Chairman, H.P. Housing & Urban Development Authority invites the online bids on percentage rate, in electronic tendering system, in **Two Cover System** for the under mentioned work from the eligible and approved Contractors/Firms/Companies registered with HIMUDA and HPPWD. The successful bidders of HPPWD must get registered in HIMUDA in appropriate class before signing the contract. (As per HIMUDA Enlistment Rules, 2018).

(i) **Name of Work:-** Construction for the development of the Educational Infrastructure at various School in H.P. under PM SHRI 2025-26. (SH: C/o Library Room & 4Nos. toilets for Govt. Model Sr. Sec. School Manali Town, Distt. Kullu, H.P.). **Estimated Cost:** Rs.20,92,725/- **Earnest Money:** Rs.41,855/- **Time Limit:** 120 Days and **Cost of Form:** Rs.1500/- + GST @18%= Total Rs.1770/- (Non-refundable).

2. **Availability of Bid Documents and mode of submission:-** The Bid documents are available on line and bid should be submitted in online mode on website <https://hptenders.gov.in>.

Bidders would be required to register in the web-site which is free of cost. For submission of bids, the bidders are required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in HIMUDA may obtain the same from the website:<https://hptender.gov.in>. Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

4. TENDER DETAILS:

The Tender Documents shall be uploaded online in Two Covers.

(a) **Cover-1:** shall contain scanned copies of all "Technical Documents/Eligibility Information".

(b) **Cover-2:** shall contain "BOQ/Financial Bid", where contractor will quote his offer in percentage rate.

(C) Cover-1 i.e. "Technical Documents/Eligibility Criteria" shall be opened first and the cover 2 i.e. "Financial bid of only those contractors shall be opened who fulfill the eligibility criteria and have uploaded the required documents in support of the same in (cover-1 scanned copies to be uploaded) as detailed below:-

- i) Certificate of valid enlistment/renewal registration of concerned class and one class below as per concerned organization enlistment rule i.e. HIMUDA and HPPWD.
- ii) GST Registration and acknowledgement of upto date filed returns of GST.

It is hereby clarified that contractors/bidders registered under the GST Composition Scheme shall not be eligible to participate in the bidding process. Any bid submitted by a contractor/bidder registered under the GST Composition Scheme shall be liable to be rejected.

- iii) Income Tax Return/clearance Acknowledgement, PAN No. and EPF Registration.
- iv) Tender form cost and earnest money will be transacted through e-payment gateway only which will be available on the portal while tendering.
- v) The contractor should not have more than two contracts at a time in hand in any HIMUDA circles and the bidder has to give/upload an undertaking to this effect that he does not have any contract or more than two contracts in hand in any HIMUDA Circle and detail of machinery Tool & Plant filled up on the format as shown in schedule 'F' with reference to clause 18 along with proof R.C., Affidavits etc. should be uploaded.


5. BID OPENING DETAILS: Technical bid shall be opened on **25.06.2026** at 10.30 hours in the office of **Executive Engineer, HIMUDA Division, Mandi, District Mandi, (HP)** by the authorized officer. The tenderers are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed or the undersigned has to be on official tour on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

6. The bids for the work shall remain valid for acceptance for a period of **50 days** after the opening of Financial Bid.

7. Bidder has to keep HIMUDA Tender Form for his future reference as uploaded by the HIMUDA on the hp tender portal. No separate tender form will be issued by the HIMUDA.

8. Objection if any will be entertained within three days of uploading of Technical Evaluation and after finalization of the same no objection at later stage will be entertained and the decision of tender inviting authority in this regard will be final.

Other details can be seen in the bidding documents (Form-6, 7/ 8). The officer inviting tender shall not be held liable for any delay due to system failure beyond his control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender.
