NOTICE INVITING e-TENDER

1. **The Executive Engineer, HIMUDA Division Ghumarwin, District Bilaspur, (HP)** on behalf of the Chairman, H.P. Housing & Urban Development Authority invites the online bids on percentage rate, in electronic tendering system, in **Two Cover System** for the under mentioned work from approved eligible contractors of HIMUDA, HPPWD and HP Jal Shakti Vibhag enlisted in appropriate class. However, successful bidder of HPPWD and HP Jal Shakti Vibhag must get registered in HIMUDA, in appropriate class before signing the contract (As per enlistment rules of HIMUDA 2018).

2. **Availability of Bid Documents and mode of submission:-** The Bid documents are available on line and bid should be submitted in online mode on website <https://hptenders.gov.in>.

Bidders would be required to register in the web-site which is free of cost. For submission of bids, the bidders are required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in HIMUDA may obtain the same from the website:<https://hptender.gov.in>. Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

4. TENDER DETAILS:

The Tender Documents shall be uploaded online in Two Covers.

- (a) **Cover-1:** shall contain scanned copies of all “Technical Documents/Eligibility Information”.
- (b) **Cover-2:** shall contain “**BOQ/Financial Bid**”, where contractor will quote his offer in percentage rate.
- (c) **Cover-1** i.e. “**Technical Documents/Eligibility Criteria**” shall be opened first and the cover 2 i.e. “Financial bid of only those contractors shall be opened who fulfill the eligibility criteria and have uploaded the required documents in support of the same in (cover-1 scanned copies to be uploaded) as detailed below:-

- Certificate of enlistment/renewal registration of only **Class- A**.
- GST Registration and acknowledgement of upto date filed returns of GST.
- Income Tax Return/clearance Acknowledgement, PAN No. and EPF Registration.
- Tender form cost and earnest money will be transacted through e-payment gateway only which will be available on the portal while tendering.
- Submission of an affidavit-cum-Undertaking for agreement of an appropriate class specialized agency as per condition No.1.1.1 of DNIT

It is also made clear that only those contractors are eligible for the above mentioned work who possess valid enlistment/renewal registration of only Class- A with HIMUDA, HPPWD and HP Jal Shakti Vibhag. However, successful bidder of HPPWD and HP Jal Shakti Vibhag must get registered in HIMUDA, in appropriate class before signing the contract (As per enlistment rules of HIMUDA 2018). All other documents uploaded should be clearly legible, failing which bidding will not be considered and be rejected outrightly. The tender form cost and earnest money will not be considered in any other mode except e-payment gateway.

- Detail of work done, work in hand detail on the required performa shown in General Rules NO.16 (if there is no work in hand, the bidder has to give/upload an affidavit to this effect that he does not have any work in hand in the entire state of HP) and Bidding Capacity, as per proforma given under General Rules No. 26.2 and detail of machinery Tool & Plant filled up on the format as shown in schedule ‘F’ with reference to clause 18 along with proof R.C., Affidavits etc. should be uploaded.

- vii) The available bid capacity will be calculated as under and assessed available bid capacity for construction works should be equal to or more than the total bid value:-

Assessed available bid capacity ($A*N*M-B$) where

A=Maximum value of Civil Engineering works executed in any one year during the last five years (up dated to the price level of the financial year in which bids are received at the rate of 8 percent a year) taking into account the completed as well as works in progress.

N= Number of years prescribed for completion of the works for which bids are invited (period up to 6 months to be taken as half year and more than 6 months as one year).

M= 2

B= Value, at the current price level, of existing commitments and ongoing works to be completed during the periods of completion of works for which bids are invited.

- viii) A contractor/firm would be considered pre-qualified if they have successfully executed similar works (without liquidated damage or compensation) in last seven years as per detailed below:-

Three similar works of 40% of the estimated cost put to tender.

Or

Two similar works of 60% of the estimated cost put to tender.

Or

One similar work of 80% of the estimated cost put to tender.

viii)The tender for composite work includes, in addition to building work, all other works such as sanitary and water supply installations drainage installation, electrical work, roads and paths etc. The tenderer apart from being a registered contractor of appropriate class, must associate himself with agencies of appropriate class that are eligible to tender for electrical works in the composite tender. Tenderer must provide test certificate of Electrical work as per guidelines of HPSEB. The main tenderer will be responsible for all approvals from appropriate authorities at his cost before handing over the work of all the components of the job in General Rules NO.29.

Xi) The agencies will also simultaneously execute the works like electrification, horticulture or external services and other building works for the same project along with this work in particular. The contractor shall afford necessary facilities for the same. No claim in the matter shall be entertained.

NOTE: The statements showing the value of existing commitments and ongoing works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Engineer-in-charge not below the rank of an Executive Engineer or equivalent.

5. SUBMISSION OF ORIGINAL DOCUMENTS: Only the 1st lowest bidder will submit all eligibility documents physically to this office as required above in point No. 4 (C) within seven days after opening the financial bid, failing which bid will not be considered. No other bidders are required to submit the documents physically.

6.BID OPENING DETAILS: Technical bid shall be opened on **24.08.2026** at 11.30 hours in the

office of **Executive Engineer, HIMUDA Division, Ghumarwin, District Bilaspur, (HP)** by the authorized officer. The tenderers are advised to be present along with original documents at the time of opening of tenders. If the office happens to be closed or the undersigned has have to be on official tour on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

7.The bids for the work shall remain valid for acceptance for a period of **50 days** after the opening of Financial Bid.

8. Bidder has to keep HIMUDA Tender Form for his future reference as uploaded by the HIMUDA on the hp tender portal. No separate tender form will be issued by the HIMUDA.

9. Objection if any will be entertained within three days of uploading of Technical Evaluation and after finalization of the same no objection at later stage will be entertained and the decision of tender inviting authority in this regard will be final.

Other details can be seen in the bidding documents (Form-6, 7/ 8). The officer inviting tender shall not be held liable for any delay due to system failure beyond his control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender.
